

## Village of Chipman Public Open House for

## Wastewater Treatment Facility Replacement

Wednesday, July 5th, 2017

**Welcome** to the Village of Chipman's Public Open House for the project titled - *Wastewater Treatment Facility (WwTF) Replacement.* This Open House event is part of the Environmental Impact Assessment (EIA) Process being conducted for replacing the Village's wastewater treatment facility.

**About the Open House** - You have a right to be informed about this project. The Open House is intended to provide an opportunity for direct public engagement regarding this project, including the project goals, objectives, engineering and construction details, and potential environmental impacts and associated mitigating measures. As the project Proponent, the Village is responsible for informing the general public, project stakeholders and interested parties about the project details. The information panels that are on display highlight key aspects of the proposed project. You are encouraged to view these panels, and engage in discussions with the project representatives by asking questions and voicing any comments or concerns regarding the project.

**About the Project** - The Village's existing WwTF was constructed in the early 1970's and has been in continuous service for more than 45-years. It has served the community well and continues to provide a good treatment performance. However, it is nearing the end of its serviceable life and the Village has started the process of developing a replacement.

The proposed new WwTF will treat the wastewater to a higher standard (to meet new federal guidelines) and discharge it directly to the Salmon River (to access higher available dilution). A new WwTF and outfall are anticipated to cost \$ 3.57 M. The Village is expect to contribute 25% of capital costs, which are anticipated to be \$ 893 000. In addition, the Village is expect to contribute 100% of all treatment system operation and maintenance costs.
